INTRODUCTION AND PROJECT SCOPE OF SERVICES

GDPM is seeking specific qualifications and technical proposals from interested environmental consultant (EC's) and testing companies. These consultants shall be capable of providing comprehensive environmental audits, site assessments, asbestos management, lead-based paint management, indoor air quality management, environmental testing services, radon gas testing including but not limited to lead, asbestos, mold, mildew, fungi, humidity and dew point. Environmental reports may be used to conduct modernization or new construction with U.S. Department of Housing and Urban Development, Ohio Housing Finance Agency, or other private funds. Environmental reports generated must meet the requirements and needs of all GDPM funders. GDPM is interested in contracting for a full range of services to be provided that will relate to its facilities and properties to be financed through performance-based tasking, or similar agreement, requiring no initial capital cost. The statement of fees is to be inclusive of all business rates.

PART I. SCOPE OF SERVICES:

These services may include but are not limited to:

1. ENVIRONMENTAL AUDITS AND SITE ASSESSMENTS:

- a. Investigate physical properties and surrounding areas.
- b. Review site history.
- c. Assess regulatory compliance issues.
- d. Perform field investigation and inspections.
- e. Conduct site-specific sampling and analysis to identify hazardous materials.
- f. Assist GDPM's Responsible Entity preform Part 58 Environmental Reviews.
- g. Develop and manage site clean-up plan.
- h. Provide specifications for abatement and remedial actions in removal or confinement of hazardous materials.

2. ASBESTOS CONSULTING:

a. Conduct inspection and assessment for suspected asbestos – containing materials.

- b. Conduct on site non destructive bulk sampling analysis of suspected material as required in accordance with Environmental Protection Agency (EPA) guidance documents.
- c. Suspected ACM selected will be submitted to a fully accredited laboratory by the National Institute of Standards and Technology (NIST) under its National Voluntary Laboratory Accreditation Program (NVLAP) to analyze by polarized light microscopy (PLM) in accordance with the prescribed EPA Test Method (EPA/600/R- 93/116), "Method for the Department of Asbestos in Bulk Building Materials", 40 CFR Part 763, Appendix A to Subpart F.
- d. The Environmental Consultant will provide GDPM a schedule for task to be performed and report completion.
- e. Asbestos technicians will be certified by the Ohio Department of Health and will perform the collection of these samples.
- f. If available review as built drawings and building specifications for any indication of building components that might be treated with or contain asbestos.
- g. Technicians will touch potential ACBM to determine its friability.
- h. Identify all homogeneous areas of friable and non friable ACBM.
- i. Provide for future reference, a source document of the asbestos inspection that identifies inventories, assesses and quantifies the ACBM including results of analytical data from each area.
- j. Prepare an asbestos inspection report that will document activities performed relative to the project. The report will include a description of the methodologies used, a tabular summary of findings/analytical results, copy of the laboratory report, and firm conclusions and recommendations regarding site conditions.

3. LEAD-BASED PAINT MANAGEMENT:

- a. Perform inspections in accordance with HUD, EPA and OSHA regulations.
- b. Compile an inventory of painted surfaces, which will be comprised of testing combinations based on room equivalents, substrates and component types.
- c. Test painted surfaces for the presence of lead based paint using a Model LPA 1×1 X Ray Fluorescence (XRF) Lead in Paint Spectrum Analyzer.
- d. Collect and prepare for lead analysis, paint chip samples, from components, which test inconclusive through XRF readings, and components not able to be tested with XRF.
- e. Compile field data on standardized forms as noted in HUD guidelines, which will be included in the final report.

- f. Prepare a report which will specify surfaces which have been tested positive, negative, or inconclusive for lead based paint and identify locations. The data will be presented on and area by area basis.
- g. Risk assessment set forth by HUD guidelines for evaluation and control of Lead-Based Paint Hazards in Public Housing.
- h. Project management and oversight of LBP abatement projects and response actions including daily monitoring of airborne concentration of lead.
- i. Develop technical specifications for abatement of lead-based paint, lead-based paint removal, project control and air monitoring as needed.

4. ENVIRONMENTAL STUDY:

- a. Site Assessment Phase I, Phase II and Phase III.
- b. Field services.
- c. Project management and consultation.
- d. Soil and groundwater investigations.
- e. Regulatory compliance negotiations.

5. INDOOR AIR QUALITY:

- a. Perform testing and sampling procedures to identify cause of poor indoor air quality.
- b. Provide study and report of the indoor environment, finding problems and develop a solution.
- c. Develop technical recommendations for improvement of indoor air quality, project control and air monitoring.

6. MOLD, FUNGI AND MILDEW ASSESSMENTS:

- a. Perform inspections and testing of potential hazards,
- b. Develop technical specifications for abatement of mold, fungi and mildew, removal of mold fungi and mildew, project control and air monitoring.
- c. Perform clearance testing following abatement.

7. RADON GAS TESTING

a. A Certified Radon Inspector must perform the work.

- b. Short-Term, Activated Carbon, Radon Test Kits for all appropriate locations based on site visits prior to testing to determine final quantity.
- c. Sampling will be conducted according to ANSI/AARST Designation MAMF-2012, Protocol for Conducting Radon and Radon Decay Product Measurements in Multifamily Building's protocol.
- d. A written report including building conditions, sampling locations,
- e. Laboratory reports, test results and recommendations.

8. FINAL REPORT(S) FORMAT & MISCELLANEOUS ITEMS

- a. Reports shall be provided in an electronic format. GDPM may request and Contractor will be expected to provide (2) original tabbed binders for each report and three (3) copies of each report on CD, DVD media or USB Flash Drive.
- b. Reports shall have a cover sheet, index (s), executive summary analysis, pictures (if applicable) and summary.
- c. Consultant will be expected to timey provide reports and responses. Typically, GDPM will expect a 30-day turn around for draft reports after GDPM give initial task assignment. The 30-day period is inclusive of any needed site inspections and testing.
- d. Upon request, Consultant is expected to draft specifications to assist with remedying uncovered environmental conditions. Specifications shall be delivered within 14 days of the request.
- e. The firm selected to provide these services will be required to assure the assessments are conducted in compliance with the Society for Testing and Materials (ASTM) practices and guidelines for Phase I ESA's Standard E1527-13 and for Phase II ESA ASTM Standard E1903-97 (most recent) and the U.S. EPA 40 CFR Part 312 Standards and Practices for All Appropriate Inquiries (AAI), as well as state and local agency requirements.
- f. The Contractor agrees to comply with the requirements as set forth in 2 CFR 255, Cost Principles for State, Local and Indian Tribe Governments; OMB Circular A 102, Grants and Cooperative Agreements with State and Local Governments
- g. Clauses required by HUD for housing authority Consultant contracts are included on forms HUD- 5370 C and provide guidance to Consultant requirements.
- h. All services and actions on behalf of GDPM by the Consultant, including meetings, discussions, site visits, etc. shall be fully documented by the Consultant. Meeting

documentation shall include a sign-in sheet, agenda to ensure an efficient meetings and recorded minutes, which shall be reviewed and commented upon by GDPM prior to being issued.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- · An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

- 1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
 - 2. The treaty article addressing the income.
- 3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
- 4. The type and amount of income that qualifies for the exemption from tax.
- 5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester,
- 2. You do not certify your TIN when required (see the instructions for Part II for details),
 - 3. The IRS tells the requester that you furnished an incorrect TIN,
- 4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
- 5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

Also see Special rules for partnerships, earlier.

What is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account; for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Line 1

You must enter one of the following on this line; **do not** leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

a. **Individual.** Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Note: ITIN applicant: Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040/1040A/1040EZ you filed with your application.

- b. **Sole proprietor or single-member LLC.** Enter your individual name as shown on your 1040/1040A/1040EZ on line 1. You may enter your business, trade, or "doing business as" (DBA) name on line 2.
- c. Partnership, LLC that is not a single-member LLC, C corporation, or S corporation. Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.

Line 4, Exemptions

- Protect your SSN.

Protect yourself from suspicious emails or phishing schemes. Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to <code>phishing@irs.gov</code>. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for Tax Administration (TIGTA) at 1-800-366-4484. You can forward suspicious emails to the Federal Trade Commission at <code>spam@uce.gov</code> or report them at <code>www.ftc.gov/complaint</code>. You can contact the FTC at <code>www.ftc.gov/idtheft</code> or 877-IDTHEFT (877-438-4338). If you have been the victim of identity theft, see <code>www.ldentityTheft.gov</code> and Pub. 5027.

Privacy Act Notice
